2. Unless otherwise approved by the Stadium Manager, a Confirmed Booking cannot be transferred to another date.

3. Payment before the Event

(a) If the application is accepted, an official letter will be mailed to the applicant and deposit is required as a confirmation of booking. i.e. The booking is not yet confirmed until the deposit is made. No amendment of booking date, time nor whatsoever will be accepted after confirmation completed;

(b) For all Confirmed Booking, the overall hire charge for the Stadium, less any reservation fee paid, shall be payable by the Hirer at least 60 days prior to the first day of the Confirmed Booking, or on or before such date as specified by the Association.

(c) At least 60 days prior to the first day of the Confirmed Booking, or on or before such date as may be specified by the Association, the Hirer shall pay the Association the amount demanded by the Association which shall be equivalent to the estimated total cost of the reimbursable charges for services and facilities required, and rights fee, if any, payable under the First Schedule.

4. Payment after the Event

Unless he has already done so, the Hirer shall within 14 days after the Event, or in the case where a demand is issued after the expiration of the said 14 days period, within such time as may be specified by the Association, pay to the Association a sum representing any outstanding charges and fees for each day of the Confirmed Booking, namely:

(a) the hire Charges (e.g. due to extension or overnight use of the stadium);

(b) the amount of extra use of service or facilities fee;

(c) the cost of restoring the stadium to original layout due to any decorations and alterations made in the Event by Hirer;

(d) any other charges, costs and expenses whatsoever due to the Association under these terms and Conditions;

(e) the amount of reimbursable charge or rights fee; and

(f) any Indemnity.
